Guarantee and Indemnity

Each Guarantor warrants that he/she is either a director of the Customer or is a shareholder in the Customer as at the date of executing this document.

By executing this Guarantee and Indemnity, each Guarantor acknowledges that they have read, understood and agree to the terms and conditions specified below:

1. In consideration of O'Connor's Operations Pty Ltd ACN 646 211 636 as trustee for the O'Connor's Operations Trust trading as O'Connors Carrying Service (**Carrier**) entering into the Terms and Conditions of Trade with, and agreeing to provide services to, the Customer, each Guarantor unconditionally and irrevocably guarantees to the Carrier the due performance of all obligations and payment of all moneys owing by the Customer to the Carrier, whether actually or contingently (**Guaranteed Moneys**);
2.
